



Instructions for New Members

Gallatin Association of REALTORS® Big Sky Country MLS

Welcome to the Gallatin Association of REALTORS* (GAR) and the Big Sky Country Multiple Listing Service (BSCMLS). To become a member of GAR and subscribe to the BSCMLS, please follow the steps below. You must complete membership paperwork with the GAR office within ten days of joining a real estate firm. Please note that we require a minimum of 3 business days after receipt of all completed forms to process your membership application.

FORMS:

- A. Complete the following form & email it in <u>PDF format</u> to **danielle@gallatinrealtors.com**, along with a copy of your State Real Estate license:
 - a. REALTOR®/Appraiser Application for Membership (page 2 of this application)

B. Payment: Once GAR Staff processes your application, you will be emailed your corresponding invoices (pro-rated by the month you join) with hyperlinks to pay the following online:

- a. BSCMLS fees and a one-time \$1000 MLS Application Fee. We accept personal checks and credit cards (Visa, MC, or AMEX).
 - Checks for BSCMLS need to be made to BSCMLS.
- b. Pay GAR/MAR/NAR dues and a one-time \$1000 GAR Application Fee. We accept personal checks and credit cards (Visa, MC, or AMEX.)
 - Checks for GAR need to be made to GAR.

CODE OF ETHICS:

Step 2

- A. After your GAR Dues and BSCMLS Fees have been paid in full, we will email you a link to take the online Code of Ethics course through the National Association of REALTORS®. You must email confirmation to GAR of completion within 30 days of joining.
 - A letter of Good Standing from your current "Primary" REALTOR Association is required if you are a member of another local association.

ORIENTATION:

- A. After you have paid your membership fees, you will also receive an email from us with instructions on accessing BSCMLS and the link to the <u>online</u> orientation. The orientation is a mandatory course, and you have 30 days to complete it from the day you are enrolled. Your membership will be suspended if you do not complete the orientation by the deadline.
- B. Failure to take the online orientation class and pass with a score of 80% or better will result in all of your BSCMLS services being suspended. If you miss the original deadline and do not complete the orientation within a total of 45 days from the enrollment date, your membership with both GAR and the BSCMLS will be terminated. You would need to pay all your application fees again to reinstate your membership.

Additional Information

- Membership as a REALTOR*/Appraiser requires you to be a member of a state association and the National Association of REALTORS* (NAR).
- If you transfer offices, there will be a \$100 Transfer fee.
- Reactivating your membership:
 - If you reactivate within the first three months of going inactive, you will not be charged a reinstatement fee for the MLS.
 - o If you reactivate with the BSCMLS within the subsequent nine months, you will be charged a \$1000 reinstatement fee.
 - o If you reactivate after 12 months, you will be charged a \$1000 reinstatement fee for each corporation you join (excluding MAR and NAR), pro-rated GAR dues, pro-rated BSCMLS fees, and any outstanding late fees or fines that may have been assessed before going inactive with either corporation.

I agree to abide by the Code of Ethics of the National Association of REALTORS®, and the constitution, bylaws, rules, and regulations of the Gallatin Association of REALTORS® (GAR), Big Sky Country Multiple Listing Service (BSCMLS), Montana Association of REALTORS® (MAR), and the National Association of REALTORS® (NAR).

I agree to arbitrate when required by the Code of Ethics and to abide by the decision of the professional standards committee of the Association, or the decision of the appeals board in the event of an appeal. I irrevocably waive all claims against the Association, or any of its officers, directors, members, or employees, for any act in connection with the business of the Association, and particularly as to its or their acts in electing or failing to elect, advance, suspend, expel, or otherwise discipline me as an applicant member. I acknowledge that if accepted as a member, and I subsequently resign from the Association or otherwise cause membership to terminate with an ethics complaint pending, the Board of Directors may condition renewal of membership upon my certification that I will submit to the pending ethics proceeding and will abide by the decision of the hearing panel. If I resign or otherwise cause membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while I was a REALTOR®.

I consent that the Gallatin Association of REALTORS® and/or Big Sky Country MLS may contact me at the specified address, telephone number, email address, or other means of communication available. This consent applies to changes in contact information that may be provided by me to one or both corporations in the future. This consent recognizes that certain state and federal laws may place limits on communications that I am waiving to receive all communications as part of my membership.

I will complete the NAR Ethics Course and the GAR and/or BSCMLS New Member Orientation Program within **Thirty (30)** days of application processing. Failure to meet this requirement will result in having my membership suspended from the GAR and/or BSCMLS. My membership will remain in a suspended status until these requirements are met. However, if I fail to meet the requirements for membership within **Forty-Five (45) days** of application processing, my membership with GAR and/or BSCMLS will be terminated. My right to reapply for membership will be subject to review by the GAR Board of Directors and/or BSCMLS Board of Directors. If reapplication is approved, I must pay a \$1000 reinstatement fee for GAR and/or a \$1000 reinstatement fee for the BSCMLS, and any late fees or association dues still outstanding. After all necessary fees have been paid, membership will be treated the same as a new applicant, including my requirement to complete the mandatory orientation within Thirty (30) days of when my reinstatement fees are paid in full.

I acknowledge that all application fees are non-refundable.

The access issued to each Participant or Subscriber is unique and strictly confidential to that person. The authorized Participant/Subscriber agrees that should disclosure of account information result in access by an unauthorized party, authorized Participant/Subscriber may be subject to penalties as follows:

- (1) An immediate fine in the amount of \$1000.00 will be assessed to the Participants account.
- (2) If the Participant/Subscriber violates the same rule a 2nd time in a 12-month rolling calendar, a \$3000.00 fine will be assessed to the Participant's account.
- (3) If the Participant/Subscriber violates the same rule a third time within the same 12-month rolling calendar, a \$5000.00 fine will be assessed to the Participants account, and the entire office will lose access to the MLS and lockbox system until all fines have been paid.
- (4) Any additional violations by the participant/subscriber of the same rule within a 12-month rolling calendar will result in the BSCMLS Board of Directors determining the appropriate course of action..

In compliance with BSCMLS Rules and Regulations, this Agreement provides for the Authorized Participant/Subscriber to gain immediate access to the MLS and public record database for the use in listing, searching, and retrieving the data contained therein. This right is contingent upon the Participant/Subscriber completing the required training course within the 30 days allowed. Failure to do so will result in suspending the right to access the MLS database.

MLS Participant/user agrees to comply with BSCMLS Rules and Regulations. Any other use, reuse, or resale of this data is prohibited. The term of this Agreement shall commence upon initiation of service to the Participant/Subscriber. This Agreement is not assignable. The Participant/Subscriber hereby indemnifies the service and any reciprocal service and agrees to hold harmless from and against all claims, losses, damages, costs, and expenses of any kind, including attorney's fees, and from liability to any person arising from a Participant/Subscriber.

BSCMLS reserves the right to disseminate member information as it deems appropriate for the purposes of association management.

Definition of MLS "Participant": Any REALTOR® of any Montana association/board shall be eligible to participate in the BSCMLS upon agreeing in writing to conform to the rules and regulations thereof and to pay the costs incidental thereto. However, under no circumstances is any individual or firm, regardless of membership status, entitled to Multiple Listing Service "membership" or "participation" unless they hold a current, valid Montana real estate broker, salesperson, or appraisal license and offer or accept cooperation and compensation to and from other Participants or are licensed or certified by an appropriate state regulatory agency to engage in the appraisal of real property.

Use of information developed by or published by BSCMLS is strictly limited to the activities authorized under a Participant's licensure(s) or certification, and unauthorized uses are prohibited. Further, none of the foregoing is intended to convey "participation" or "membership" or any right to access information developed by or published by a board multiple listing service where access to such information is prohibited by law.

GAR Dues and BSCMLS Fees Schedule

One-time GAR Application fee: \$1000.00
One-time BSCMLS Application fee: \$1000.00

Quarterly MLS Subscription fee: \$150.00 for REALTORS (prorated \$50/month) | \$105 for Appraisers (prorated \$35/month)

Reinstatement fee: \$1000.00 (applies if you have been inactive with the BSCMLS for more than 90 calendar days)

BSCMLS Office Transfer Fee: \$100.00

New company processing fee: \$2,100.00 (if applicable)

New Members: The Application Fees & Dues Schedule below shows the application fees with REALTOR® dues for GAR, MAR, and NAR. GAR operates on a fiscal year (October 1st to September 30th); MAR and NAR operate on a calendar year. As a primary or secondary REALTOR® member with GAR, your annual dues are due by September 30th. (Primary members pay their state and national dues through GAR and whose principal broker also holds membership in GAR. Secondary membership is available only to REALTORS® who already have primary membership in another association.)

Returning Members: GAR Membership dues shall be pro-rated for any licensee included on a certification form submitted to the Association who during the same calendar year applies for REALTOR® membership in the Association. However, membership dues shall not be pro-rated if the licensee held REALTOR® membership during the preceding calendar year.

All GAR, MAR, and NAR Annual Membership Dues and Application Fees are <u>non-refundable and subject to change</u>. The NAR Annual Ad Campaign is NOT pro-rated
